

Assembly & Operating Instructions

Ironmaster Cable Tower Seat

Congratulations on your purchase of this fine Ironmaster product. Be sure to read and understand the operating instructions to achieve the best performance and avoid injury.

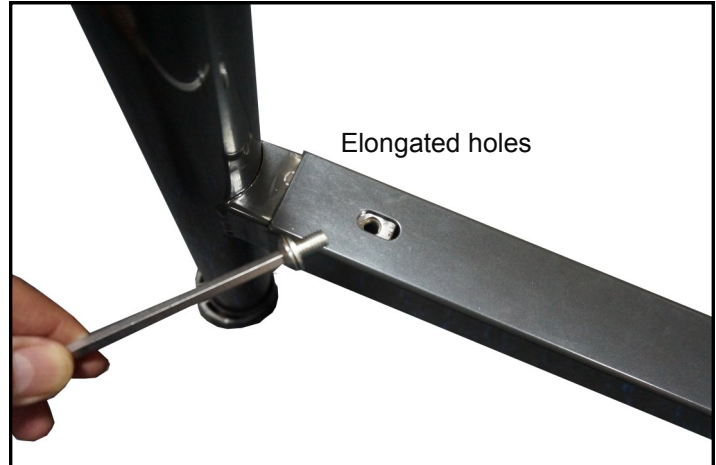
The Ironmaster Cable Tower seat is an add on to the Ironmaster Cable Tower instead of using the Super Bench.

CAUTION: The Seat is not designed to be used as a stand alone item, it must be attached and secured to the Ironmaster Cable Tower prior to use.

Step 2: Slide the BASE FOOT Stub into the SEAT FRAME as shown above. Secure bolts and washers.

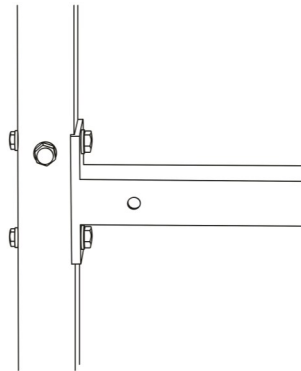
Step 3: Once the BASE FOOT and SEAT FRAME are together, there are two ways to adjust height and fine tune. First, use the elongated holes to adjust overall seat height. Second, use the Eccentric End Caps to fine tune and to compensate for uneven flooring—only if necessary. Twist the End caps to the desired position. If the caps are on too tight you may need to tap them off with a hammer or wrench and push back in place.

Note: It is recommended to connect the SEAT to the TOWER before making the height adjustments.

Attaching Cable Tower Seat to Cable Tower:



Locate the PULL PIN which is under the front of the seat pad. Unscrew the PULL PIN until the Pin is in the unlocked position. Pull the PULL PIN and slide the CABLE TOWER SEAT onto the Cable Tower stub.



Once the PULL PIN snaps into the stub hole, tighten the PULL PIN to the locked position and make any necessary adjustments to seat height or leveling using the methods show on previous page.



The CABLE TOWER SEAT may also be used with the Ironmaster HYPERCORE attachment to make it a stand-alone use as shown above.

Note: Although this attachment has been tested as safe, use caution and exercise in a normal, safe manner to avoid movements that may cause any tipping of the equipment.
